The 2020 meeting will now be held from Friday February 26, 2021 to Saturday, February 27, 2021.

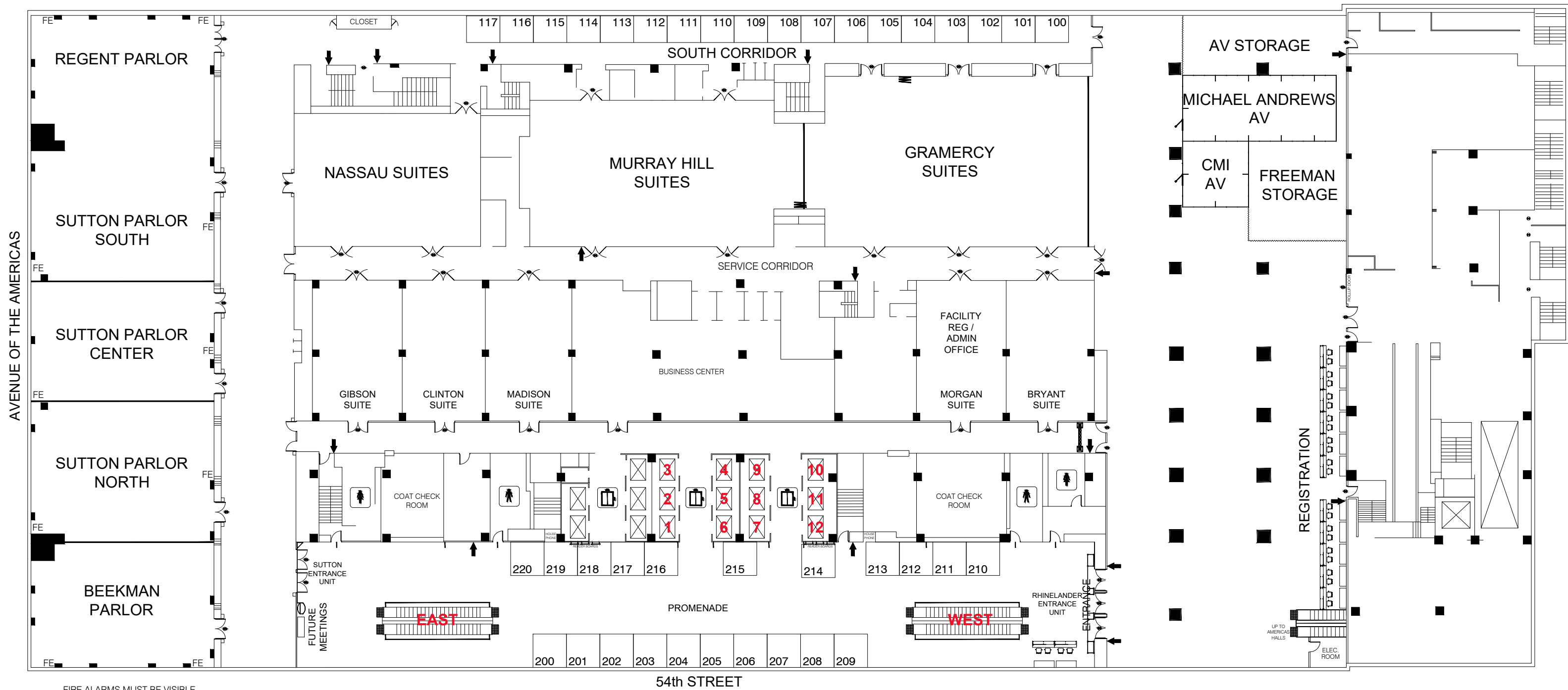
